BYLAW NO. 17-2023**

BYLAW NO. 17-2023 OF LAC STE. ANNE COUNTY, IN THE PROVINCE OF ALBERTA, UNDER THE PROVISIONS OF SECTION 382 OF THE MUNICIPAL GOVERNMENT ACT AND AMENDMENTS THERETO:

WHEREAS, the Council of Lac Ste. Anne County deems it necessary to levy a Special Tax to cover a portion of the capital cost of the installation of Sewage Facilities on the land fronting on any street or lanes served or benefited by sewer facilities within the Hamlet of Cherhill.

NOW THEREFORE, the Council of Lac Ste. Anne County, in the Province of Alberta duly assembled enact as follows:

- 1) That the County Manager be authorized to levy a uniform Special Capital Cost Recovery Tax against all frontage for the Hamlet of Cherhill:

Schedule "A" Hamlet of Cherhill 5,550 lin. ft. @ \$0.89 = \$4,939.50

- 2) That the monies shall be used solely for the purpose of recovering a portion of the Capital costs to install a new wastewater collection system and lift stations (2003).
- 3) This Bylaw shall come into effect on January 1st, 2023.
