RESERVATIONS

Overnight camping reservations for all County-owned campgrounds (Lessard Lake Public Campground, Paddle River Dam Campground (Peter’s Pond), and Paddle River Dam Campground (Boat Launch) can be made by contacting the campground caretakers directly (starting May 1, 2023 at 9:00 am) at the numbers listed below. **Any calls/messages prior thereto will be deleted, and not responded to.** Payment for the first night is required at time of reservation to confirm your spot. Cancellations with a minimum of 48 hours’ notice will be refunded. All other cancellations or “no shows” will forfeit the prepaid first night fee.

SEASONAL SITES

The County offers seasonal sites at the Lessard Lake Public Campground, Paddle River Dam Campground (Peter’s Pond) and Paddle River Dam Campground (Boat Launch).
