# PRIVATE RESIDENTIAL DUST SUPPRESSANT

Lac Ste. Anne County will continue with the Dust Suppressant Program at a cost recovery price. There are two choices available, please refer to page 2 for your options. The lifespan of dust suppressant depends on traffic type and volume, alignment, moisture, soil type and maintenance.

The effectiveness of applied dust suppressant is not guaranteed by the County because there is no way to predict its lifespan. Dust suppression is applied once all frost has dissipated from the road. Dissipation typically occurs in and around the end of June each year. Please note that residents will experience dust until treatment has been applied.

- 4. Lac Ste. Anne County will not assume responsibility for any leaching, and/or damage to trees, shrubbery and grass
- 5. Lac Ste. Anne County reserves the right to maintain treated sections of roadway as deemed necessary



- 6. The Applicant acknowledges, understands and accepts the above conditions, and further requests Lac Ste. Anne County to conduct dust control
- 7. Prior approval by Lac Ste. Anne County must be obtained before any dust control agent is placed on a public roadway by any person
- 8. Lac Ste. Anne County does not guarantee the effectiveness of the dust control agent or application in any way
