10:00 A.M. Public Hearing re: Bylaw 24-2014-05-18

Reeve Blakeman declared the Public Hearing to review Bylaws #24-2014-05-18 be open at 10:09 a.m.

Development Authority Presentation

Reeve Blakeman requested Planning and Development Manager, Matthew Ferris to present the information regarding Bylaw #24-2014-05-18 for the Public Hearing.

Mr. Ferris summarized his presentation as follows:

The Public Hearing must be held prior to second and third reading of a Land Use Bylaw amendment, in accordance with section 962 of the Municipal Government Act. First reading of Bylaw #24-2014-05-18 was passed on August 1, 2018.

Pending legislation at the Federal and Provincial levels will make it legal for cannabis to be produced, sold, and consumed across Canada. Municipalities are empowered to set their own land use regulations under the provincial and federal framework. The amendments to the Land Use Bylaw will address the demand for development of cannabis-related uses in Lac Ste. Anne County, while ensuring these uses are appropriate for the context of their location within the County. The amendments will address Cannabis-related land uses by:

- Defining "Cannabis Retail Sales" and "Cannabis Production" as land use classes;
- Making Cannabis Retail Sales a discretionary use in the Hamlet Commercial and Highway Development districts;
- In the Industrial district, changing the language from Medicinal Marijuana Production to Cannabis Production in the list of uses as a discretionary use;
- Outlining requirements for development permit applications for cannabis related uses;
- Outlining development standards for Cannabis-related uses, such as proof of provincial license, details of site plan and surrounding uses, and a 100 m setback distance from schools and provincial healthcare facilities;
- Removing outdated references to Medicinal Marijuana Production all Cannabis
 production (whether medicinal or recreational) will now be covered under the
 "Cannabis Production" use class. Provincial legislation requires that cannabis retailers
 be located no closer than 100 m from schools and provincial healthcare facilities. The
 setbacks in the Land Use Bylaw are proposed to match this 100 m, both for Cannabis
 Retail Sales and Cannabis Production.

McCullough Center:

Planning and Development spoke with the manager of the McCullough Center in Gunn, who stated that the Center itself had no comment, and that the separation distance should be decided by the Province. The Alberta Gaming and Liquor Commission has confirmed that the McCullough Center in Gunn is not considered a Public Healthcare Facility for the purposes of the Cannabis legislation. Therefore, there is no provincially-mandated 100 m setback for that facility.

The Planning and Development Department has received a few phone calls looking for information regarding the changes to the LUB regarding Cannabis, but no concerns or comments have been received.

Reeve Blakeman asked if there was anyone in attendance that wishes to speak for or against this matter.

Some members of the Public had concerns regarding the sales of cannabis in the Hamlets of Darwell and Sangudo. It was felt by some that cannabis sales should not be allowed at the old CIBC building in Sangudo and none within Darwell.

Matthew Farris, Planning and Development Manager, responded to the issues brought forward as follows:

There are currently no permits in place or applications before the County regarding cannabis facilities in Darwell or Sangudo.


