

**LAC STE. ANNE COUNTY
PROVINCE OF ALBERTA
BYLAW #17-2025**

A BYLAW FOR LAC STE. ANNE COUNTY FOR THE PURPOSE OF CLOSING PUBLIC TRAVEL AND DISPOSING OF PORTIONS OF A PUBLIC MUNICIPAL ROAD ALLOWANCE IN ACCORDANCE WITH SECTION 22 OF THE MUNICIPAL GOVERNMENT ACT, CHAPTER M26.1, REVISED STATUES OF ALBERTA 2000, AS AMENDED.

WHEREAS, the piece of land hereafter described is no longer required for public travel;

AND WHEREAS, notice of intention of the Council to pass a bylaw has been mailed by regular mail to persons registered or assessed as the owners of the land abutting upon the portion of either roadway so proposed to be closed, at least two weeks before date fixed for second reading of the bylaw;

AND WHEREAS, notice of the intention of Council has been published through written notice to landowners advertised in the Lac Ste. Anne Bulletin and within ½ mile radius of the land subject to the proposed road closure;

AND WHEREAS, notice of the intention of Council to pass a bylaw has been given in accordance with Section 606 of the MGA and letters sent out August 15, 2025;

AND WHEREAS, Council was not petitioned for an opportunity to be heard by a person claiming to be prejudicially affected by the bylaw;

NOW THEREFORE, be it resolved that Council of Lac Ste. Anne County does hereby close the following roadway for the purpose of creation of a title (disposal), subject to any rights of access granted by any other legislation or regulation, in accordance with the attached Schedule "A".

1. This Bylaw may be cited as "Road Closure – Mako – portion of Range Road 73 and Township Road 562 amalgamated with NE 09-56-07 W5M Bylaw".

This Bylaw shall come into force and have effect from and after the date of third reading thereof.
